GENERAL TERMS AND CONDITIONS

1. Meander Valley Community Radio, Inc. ("MVCR") reserves the right to:
 - (a) Refuse at its discretion to accept any sponsorship material that in the opinion of MVCR is not consistent with its sponsorship guidelines or does not meet the technical linguistic or quality standards as determined by MVCR.
 - (b) Change the rates, terms and conditions at any time.
 - (c) Cancel, re-schedule or replace any MVCR Program or sponsorship break.
 - (d) Re-schedule sponsorship announcement booking at any time.
As a courtesy, MVCR will advise affected sponsors at least 30 days prior to implementing any changes to the rates, terms, conditions or scheduling associated with their sponsorship agreements.
2. If a sponsorship booking is made in connection with a particular MVCR Program and that particular program is cancelled, the sponsor may have the booking rescheduled to a mutually acceptable time or cancel the booking without charge.
3. For booking cancellations made within 30 days of the first day of broadcast, or production cancellations made within 24 hours of the MVCR recording session, MVCR will be entitled to payment as if the sponsorship had been broadcast or the production had taken place in accordance with the original booking.
4. While every care is taken, MVCR gives no guarantee about the proximity of sponsorships for rival products.
5. All sponsorships must be paid in full before the first date of the broadcast unless credit terms have been previously agreed with MVCR. MVCR retains the right to refuse to extend credit to any sponsor.
6. MVCR will archive sponsorship material for one year after the first date of broadcast. Any further archiving of sponsorship material is the responsibilities of the Sponsor.
7. In accordance with the Community Broadcasting Association of Australia's Codes of Practice, sponsors may not influence editorial decisions affecting the content or style of individual programs or overall station programming.
8. This agreement shall commence on signature date and shall continue unless terminated by either party after 30 days' notice in writing.
